## **How Long Does It Take to Get a VA Disability Claim Rating?**

You can file a VA disability claim anytime. However instead of the claim being backdated to the date of his retirement, it'll be effective as of the date that he files the claim. I'd strongly recommend filing the claim with the assistance of a Veteran Service Officer from your local chapter of the Veterans of Foreign Wars, or Disabled American Vets, or the American Legion, or even MOAA.

But unless you are just leaving the military, with well-documented and easily accessible service treatment records, this isn't the best approach.

The VA cannot reject claims for VA disability benefits for chronic pain merely because the pain cannot be explained. Remember that the effective date general rule says that the effective date for your disability compensation rating is the later of the date the VA receives the claim or the date the entitlement arose. And the VA often tries to apply this general effective date rule to VA increased rating claims. But the VA is often wrong.

Preparing to Submit a VA Disability Claim. The VA Disability Process takes time, but you can help it along by submitting a clear and complete VA Disability Claim (a “fully developed claim”). The first thing you should do is submit VA Form 21-0966, Intent to File a Claim. This will guarantee that the effective date for your conditions is the earliest date you can get.
